

Tuesday, 24 July 2018

Madison County Board of Supervisors met in regular session on 24 July 2018 at 9:00 a.m. in the conference room. Chairman Clifton called the meeting to order with Supervisors Duff present and Price present via telephone.

Duff moved, Price seconded, to approve the consent agenda; motion carried unanimously. Received and filed was the resolution of the Madison County Courthouse Security Committee.

Duff moved, Price seconded, to approve use of Madison County grounds application by Winterset High School band for Ice Cream on the Square 9 AUG; motion carried unanimously.

Elizabeth Hoenig met with the Board to request permission to establish an all-weather piano in the courtyard for warm-weather months. Clifton stated that he would like to visit with other towns that have community pianos before the Board makes a decision on this request.

The Board reported on their boards. New business discussed included directing Auditor Burhans to draft a resolution to appoint Jeff Nicholl as interim I.T. Administrator and declining Winterset Community School District's offer to gift their administration building to the County.

Co. Engineer Todd Hagan met with the Board. Sealcoating and micro-surfacing portion of the Bevington Park Rd project will begin on 25 JUL, and the pre-construction meeting for Earlham Rd will be held on 25 JUL.

Following public input, Duff moved, Price seconded, to adjourn the meeting at 9:38; motion carried unanimously.
