

Ia Code 53.20 (2) says "Results from the special precinct shall be reported separately from the results of the ballots cast at the polls on election day. The Commissioner shall for general elections also report the results of the special precinct by the resident precincts of the voters who cast absentee and provisional ballots. For all other elections, the commissioner may report the results of the special precinct by the resident precincts of the voters who cast absentee and provisional ballots, or may report the report the absentee results as a single precinct.
